### RULES

Proof of negative Coggins test required. Current health papers issued within the past 30 days must accompany out-of-state equine.

No entry to **show** grounds prior to 11:00 am day of the show (August 6, 2025) and no overnight stalling available. Please tie to your trailer.

Please use the McKinley Avenue entrance to the competition area.

Entry fee includes one (1) day pass for the contestant if submitted prior to August 1, 2025. All others must pay the daily gate fee. No sign-up by phone will be accepted. Sign-up date is the one postmarked on envelope or date money is received.

Competition is open to teams (or pairs) only. Each driver and assistant and each animal may enter only one (1) time per class (This means one time only!) in each division of the Gambler's Choice and Feed Race (i.e., you could enter in each the miniature, mule, pony, and horse divisions).

Farm harness may be used. The committee will provide contest vehicle appropriate for each division.

Obstacle diagram, feed race diagram and specific rules will be handed out to each participant upon check-in the day of the competition.

Your time to drive the course will be determined by when the entry is turned in – reverse order will be observed – in other words, the earlier entries will drive last, with those signing up last driving first, etc. Mail entries are encouraged but entries will be accepted until 15 minutes prior to the class starting.

There will be an established time limit for each competitor.

The Judges will determine all scores and penalties for each obstacle used.

Committee reserves the right to divide or combine classes as they feel necessary.
