To Whom It May Concern:

It is time for the 2025-2026 Winter Storage Season, on the Boone County Fairgrounds. Below are the dates and times available for the drop off of your RV, boat, or vehicle, to the grounds.

Deadline to return the enclosed form, filled out completely, with the \$35 Administration Fee is October 8, 2025. Checks only please, made payable to "Big Thunder Grange #1940".

PLEASE NOTE - RETURNING THIS FORM, WITH PAYMENT, WILL ONLY ENSURE A RESERVATION FOR THE FOUR DATES LISTED BELOW. IF YOU DO NOT STORE ON ONE OF THE LISTED DATES, SPACES WILL BE GIVEN OUT ON A FIRST COME, FIRST SERVED BASIS. NO SPACES WILL BE HELD! We are sorry for any inconvenience, but this has become necessary, due to the high volume of special requests, and limited space.

2025 Drop off dates & times: Saturday, October 18: 9 am - 2 pm

Saturday, October 25: 9 am - 2 pm

Sunday, October 19: 9 am - Noon

Sunday, October 26: 9 am - Noon

For those who do not make it on the above listed dates, Saturday, November 1, from 9 am - 2 pm, will be available, but only on a first come, first served basis. There will be no assurance of space, as any potential new storage customers will be pushed to store on this date also.

Also, if you have sold the item you had stored with us and intend to bring something different, it must be within 2' of the length of the previous item. If you plan to store the item you had and wish to bring an additional item, the new item must be brought out on Saturday, November 1, from 9 am - 2 pm.

The cost for storage is \$10.00 per linear foot (indoor), or \$8.00 per linear foot (open barn & outside) of your RV, boat, or vehicle. All items will be measured to keep our records current. Items are measured at the longest point, from tip to tip, (trailers included-as it applies). NO JACK STANDS ALLOWED. NO TRICKLE CHARGE. NO TONGUE LOCKS. REMOVE PROPANE TANKS. Payment is due on the day of drop off. Checks only please, made payable to "Boone County Fair Association."

All entry to the grounds is to be through <u>Gate 1</u>. Proceed to the Ticket Office. Your item will be measured, and your contract will be completed with you. Please send in your information sheet, along with the \$35 Administration Fee, made payable to "Big Thunder Grange #1940". This will allow for the contract to be partially filled out, before you arrive, and aid in keeping things moving a bit quicker. Please be patient!

There is no early release offered. BCFA will not be storing any electric vehicles.
